Send your entry via a valid email address to blog@popcap.com. Your entry must meet all of the Submission Requirements (as set forth below) and Content Restrictions (as set forth below). Your lyrics shall be referred to in these Rules as the "Submission". The responses will be judged based on the following criteria ("Judging").

Criteria"): Creativity, Originality, and Relevance to original question. Judging will be performed by qualified individuals at PopCap. All answers must be received within the Contest Period in order to be eligible. Winners will be chosen and notified after 5:00:00 pm PT on September 29, 2011.

- 4. Upon successful completion of the appropriate entry instructions located on the website, you will be entered in the Contest.  - L. content involving material that promotes bigotry, racism, hatred or harm against any group or individual or promotes discrimination based on race, sex, religion, nationality, disability, sexual orientation, age or any basis protected by federal, state, provincial, territorial or local law, ordinance, or regulation;
 - M. content that denigrates, disparages or reflects negatively on the Sponsor, or its products or its employees, or on any other person, company, product, show or service;
 - N. audio content owned by any third party; and

O. material that is unlawful, in violation of or contrary to the laws or regulations in any jurisdiction where the Video Submission is created.

If a Submission includes any of the prohibited elements listed above, the Submission will be disqualified, along with the Participant who submitted it. By submitting a Submission, each Participant agrees to be bound by these Official Rules and the decisions of the judges.
